## [CoI into Construction Works at and near Hung Hom Station Extension under Shatin to Central Link Project conducts preliminary hearing today](#)

The following is issued on behalf of the Commission of Inquiry into the Construction Works at and near the Hung Hom Station Extension under the Shatin to Central Link Project:

The Commission of Inquiry into the Construction Works at and near the Hung Hom Station Extension under the Shatin to Central Link Project (the

Commission) conducted a preliminary hearing today (May 6) in relation to the expanded part of its terms of reference at the hearing room on 1/F of the former Tsuen Wan Law Courts Building, 70 Tai Ho Road, Tsuen Wan, New Territories, Hong Kong.

As revealed in the opening address by the Counsel for the Commission, the Commission has issued letters requesting witness statements and other documentation from a number of relevant parties. The Commission has also served "Salmon letters" (letters giving advance notice to entities that might be the subject of criticism) on the parties listed below.

- (1) Transport and Housing Bureau;
- (2) Highways Department;
- (3) Development Bureau;
- (4) Buildings Department;
- (5) MTR Corporation Limited;
- (6) Leighton Contractors (Asia) Limited;
- (7) Wing & Kwong Steel Engineering Co Limited; and
- (8) PYPUN-KD & Associates Limited.

These parties have been asked to consider participating in, and having separate legal representation at, the substantive hearing in relation to the expanded part of the Commission's terms of reference.

The above-mentioned parties have provided/will provide witness statements and documents to the Commission. Unless notified otherwise, all individuals providing witness statements to the Commission will be required to give evidence at the substantive hearing.

The Commission also dealt with other procedural matters at the preliminary hearing, including the default language of the hearing, access to documents and use of materials provided by the Commission, written witness statements and responsive statements, participation and legal representation of the parties, the hearing procedure and seating arrangements in the hearing room.

The Commission will conduct the hearings in English, and will provide simultaneous interpretation services when appropriate. Unless otherwise directed, all hearings will be open to the public. No photography or audio/video recording is allowed at the hearing venue.

The Commission will hold the substantive hearing to take factual evidence in relation to the expanded part of the inquiry at the above-mentioned hearing room from May 27 to June 19 inclusive. The substantive hearing shall be subject to any adjournments that the Commission may consider necessary from time to time. Unless otherwise directed by the Commission, the substantive hearing will be held from 10am to 1pm and from 2.30pm to 5pm on weekdays. The Commission may consider holding the substantive hearing on Saturdays during the said periods if necessary.

## Chinese Opera Festival to premiere new Cantonese opera "A Love Poem Stained with Blood"

Local Cantonese opera veterans will join together in performing a new Cantonese opera entitled "A Love Poem Stained with Blood" to mark 10th anniversary of the inscription of Cantonese Opera on the UNESCO Representative List of Intangible Cultural Heritage of Humanity. The new opera is also one of the highlights of the 10th Chinese Opera Festival and the 30th anniversary of the Hong Kong Cultural Centre.

"A Love Poem Stained with Blood" is written by Sun Kim-long and endeavours to pass the genre from veterans of the art to a younger generation of actors. Consequently the cast features both renowned veterans and rising stars of Cantonese opera, including Sun Kim-long, Nam Fung, Yuen Siu-fai, Tang Mi-ling, Lui Hung-kwong, Johnson Yuen and Chan Kei-ting.

The story takes place during the last years of the Ming dynasty. A scholar, Hou Chaozong, has fallen in love with a courtesan, Li Xiangjun, after they meet in a brothel in Nanjing. The two are engaged to be married. Ruan Dacheng, who has sided with remnant eunuch forces holding sway over state affairs, wants to lure Hou to join his faction, and offers the dowry secretly to Li. But seeing through his evil intent, Li rejects the offer. Ruan then frames Hou as colluding with ministers like Zuo Liangyu to overthrow the regime, thus forcing Hou to flee. Hou, a man of letters and a member of the literary and political party Fu She, and Li, an intelligent and artistically accomplished beauty, are both real figures in Chinese history. At which point do their lives take a downturn? How do their breakup and reunion articulate with the vicissitudes of the country? What is the relationship between Hou and his best friend Yang Longyou?

This adaptation is written by Sun based on "The Peach Blossom Fan" by Kong Shangren of the early Qing period. Through the love story of Hou and Li, the play traces the decline of the Ming period, but offers an unexpected ending.

The new Cantonese opera "A Love Poem Stained with Blood" (with Chinese and English surtitles), presented by the Leisure and Cultural Services Department, will be staged at 7.30pm on June 21 and 22 (Friday and Saturday) at the Grand Theatre of Hong Kong Cultural Centre; and at 2.30pm on June 30 (Sunday) at the Auditorium of Tuen Mun Town Hall. Tickets price ranging from \$180 to \$480 are now available at URBTIX ([www.urbtix.hk](http://www.urbtix.hk)) and the Xiqu Centre Ticket Office. ## **Temporary closure of some LCSD leisure and sports facilities**
