## Hong Kong Customs combats sale of infringing items at mobile hawker stalls (with photos)

Hong Kong Customs conducted an operation against the sale of infringing items at mobile hawker stalls in Central district on three consecutive Sundays — January 13, January 20 and January 27. During the operation, about 900 items of suspected infringing goods with an estimated market value of about \$70,000 were seized.

Customs has stepped up enforcement actions against infringing activities prior to the Lunar New Year. Multiple mobile hawker stalls selling suspected infringing goods in Central were raided and about 900 items of suspected infringing goods were seized including clothing, leather products, watches, shoes and eyeglasses.

During the operation, Customs arrested five men and two women, aged from 26 to 46.

Customs will continue to step up inspection and enforcement to combat infringing activities during the Lunar New Year period.

Under the Trade Descriptions Ordinance, any person who sells or possesses for sale any goods with a forged trademark commits an offence. The maximum penalty upon conviction is a fine of \$500,000 and imprisonment for five years.

Under the Copyright Ordinance, any person who sells or possesses for sale any infringing goods commits an offence. The maximum penalty upon conviction is a fine of \$50,000 per infringing copy and imprisonment for four years.

Mr Lau congratulated the volunteer leaders and youths who received the awards. Speaking at the presentation ceremony, he said that uniformed groups have always been reliable partners of the Government in carrying out youth development work. By providing diverse activities and training for youths to develop a positive attitude and can-do spirit, uniformed groups have helped their members to become outstanding leaders and good citizens. Their activities and training have also enabled young people to broaden their horizons beyond regular classes, enhance their confidence and sense of responsibility, and learn the benefits of co-operation and discipline with the aim of attaining whole-person development, he said. ### CHP investigates influenza A outbreak at primary school in Sha Tin

The Centre for Health Protection (CHP) of the Department of Health is today (January 28) investigating an influenza A outbreak at a primary school in Sha Tin, and again reminded the public to maintain strict personal and environmental hygiene against influenza.

The outbreak involves 12 boys and 12 girls aged 6 to 8 who have developed fever, cough and sore throat since January 11. All of them sought medical attention. Among them, one student required hospitalisation and was discharged following treatment. All patients are in a stable condition.

The nasopharyngeal aspirate of one affected student tested positive for influenza A (H1) virus upon laboratory testing.

Officers of the CHP have conducted a site visit and advised the school to adopt necessary infection control measures against respiratory infections. The school has been put under medical surveillance.

A spokesman for the CHP said, "To prevent outbreaks of influenza and other respiratory infections, it is of prime importance that children with fever, regardless of the presence of respiratory symptoms, should not be allowed to attend school. They should seek medical advice and avoid school till 48 hours after the fever has subsided. Schools should also measure and record students' body temperature properly."

Schools are reminded to follow the <u>Guidelines on Prevention of Communicable Diseases</u> on preventive and control measures as well as management of outbreaks, which should be reported to the CHP for prompt follow-up.

"The latest surveillance data indicated that the local seasonal influenza activity may remain at an elevated level for some time. We urge the community to continue heightening its vigilance against seasonal influenza. As young children are particularly affected in the influenza season, we appeal to parents who have not yet arranged vaccination for their children in this season to do so as soon as possible to strengthen their personal protection," the spokesman said.

Apart from children, people aged 50 to 64 years, the elderly and those with underlying illnesses who have not yet received influenza vaccination this season are also urged to get vaccinated as early as possible to prevent seasonal influenza as it takes about two weeks for antibodies to develop in the body after vaccination. Medical advice should be sought promptly if influenza-like symptoms develop so that appropriate treatment can be initiated as early as possible to prevent potential complications. Parents and carers are reminded to render assistance in prevention, care and control for vulnerable people.

Besides receiving seasonal influenza vaccination as early as possible for personal protection, the public should maintain good personal and environmental hygiene for protection against influenza and other respiratory illnesses. ### Hong Kong Customs seizes suspected cannabis buds (with photo)

Hong Kong Customs today (January 28) seized about 3.1 kilograms of suspected cannabis buds with an estimated market value of about \$650,000 at Lok Ma Chau Spur Line Control Point.

Customs officers intercepted a 33-year-old incoming male passenger at Lok Ma Chau Spur Line Control Point this morning and found in his rucksack about 3.1kg of suspected cannabis buds concealed inside tinfoil packets.

The male passenger was thus arrested and investigation is ongoing.

Under the Dangerous Drugs Ordinance, trafficking in a dangerous drugs is a serious offence. The maximum penalty upon conviction is a fine of \$5 million and life imprisonment.

Customs also reminds that cannabis and tetrahydro-cannabinol (THC) are classified as dangerous drugs under the Ordinance. Importation of products (including food and drinks) containing cannabis or THC into Hong Kong is prohibited unless the relevant provisions in the Ordinance are complied with. In order to avoid breaching the law inadvertently, special attention should be paid to the packaging labels of food and drinks.
