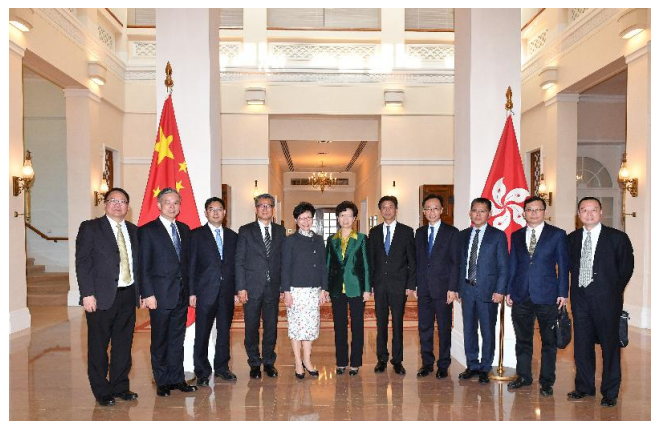


CE meets Governor of Guizhou Province (with photos)

The Chief Executive, Mrs Carrie Lam, met the Governor of Guizhou Province, Ms Shen Yiqin, at Government House this afternoon (October 9). The Financial Secretary, Mr Paul Chan, and the Secretary for Constitutional and Mainland Affairs, Mr Patrick Nip, were also present.

Mrs Lam welcomed Ms Shen's first visit to Hong Kong in her present capacity to attend an event on economic, trade and tourism promotion between Guizhou and Hong Kong to be held tomorrow (October 10) and wished the event every success. Noting that exchanges between the governments of the two places are frequent, Mrs Lam said that Mr Chan attended the China International Big Data Industry Expo 2018 in Guiyang a few months ago; the Vice-Governor of Guizhou Province, Mr Lu Yongzheng, visited Hong Kong in the middle of this year to attend a trade promotion event; and the Secretary for Development, Mr Michael Wong, led a delegation to Guiyang earlier to attend the 2018 Mainland and Hong Kong Construction Forum. All of these visits have demonstrated that Guizhou and Hong Kong attach great importance to the co-operation between the two sides, Mrs Lam said.

Mrs Lam said that Guizhou possesses abundant resources, has seen rapid development in recent years and holds immense growth potential, while Hong Kong, being the largest source of external investment in Guizhou, is an excellent platform to attract foreign capital for Guizhou and help Guizhou enterprises to "go global". She said that with the commissioning of the Hong Kong Section of the Guangzhou-Shenzhen-Hong Kong Express Rail Link last month, it only takes around five hours to travel from Hong Kong West Kowloon Station to Guiyang North Station, bringing immense benefits for further co-operation between the two places. Given that Guizhou is striving to develop its big data industry with remarkable results and that Hong Kong is proactively advancing the development of innovation and technology, including biomedicine, artificial intelligence and smart city initiatives, Mrs Lam expressed the hope that the two places will explore more room for co-operation in relevant areas.

Police today (October 9) appealed to the public for information on a man who went missing in Chai Wan.

Cheung Siu-lun, aged 34, went missing after he left a hostel in Shau Kei Wan Main Street East on October 3 morning. Staff of the hostel made a report to Police yesterday (October 8).

He is about 1.7 metres tall, 69 kilograms in weight and of medium build. He has a round face with yellow complexion and short black hair. He was last seen wearing a grey short-sleeved shirt, black trousers, black sports shoes, a pair of glasses and carrying a black shoulder bag.

SCED visits Yau Tsim Mong District **(with photos)**

The Secretary for Commerce and Economic Development, Mr Edward Yau, visited Yau Tsim Mong District today (October 9) to get a better understanding of the district's latest developments and needs. He visited Mong Kok Post Office and a non-profit-making organisation, Life Workshop, and met with members of the Yau Tsim Mong District Council (YTMDC).

Mr Yau first visited REstore and IUP of Life Workshop where he learnt about the operation of the non-profit making organisation and took the opportunity to chat with young people there. At REstore, Life Workshop organises traditional handicraft workshops and sells products from traditional stores in the district with new packaging and innovative design under the "Kengaku" Small Shop Handcraft Master Nurturing and Community Revitalisation Project. IUP meanwhile sells various products designed by local illustrators and craftspeople.

He then toured Mong Kok Post Office and was briefed by post office staff on the concept of user-oriented design adopted in the renovation work completed in 2011. In the project, the Hong Kong Design Centre was commissioned by Hongkong Post to advise on the design of the renovation. By identifying customer needs and user experiences, the creative design concept helps enhance both the service area and the efficiency of the post office.

Mr Yau said the user-oriented design enables the post office to offer better service, enrich customer experience, improve operational efficiency and provide a better working environment for staff.

Before concluding the district visit, Mr Yau exchanged views with YTMDC members on issues such as communication services and trade at a meeting. He also took the opportunity to update the members on the work of the Commerce and Economic Development Bureau.



[Operator and manager of unlicensed guesthouses fined](#)

A man was fined \$12,000 at the Kowloon City Magistrates' Courts today (October 9) for contravening the Hotel and Guesthouse Accommodation Ordinance.

The courts heard that in August 2016 and October last year, officers of the Office of the Licensing Authority (OLA), the Home Affairs Department, inspected two suspected unlicensed guesthouses on Tung Choi Street and Canton Road in Mong Kok. During the inspections, the OLA officers posed as lodgers and successfully rented rooms in these guesthouses on a daily basis.

According to the OLA's records, these guesthouses did not possess licences under the Ordinance on the days of inspection. The man responsible for operating and managing the premises was charged with contravening section 5(1) of the Ordinance.

A department spokesman stressed that operating or managing an unlicensed guesthouse is a criminal offence and will lead to a criminal record. Upon conviction, the offender is liable to a maximum fine of \$200,000 and two years' imprisonment.
