Red tide sighted

A red tide has been sighted over the past week, an inter-departmental red tide working group reported today (June 1).

The red tide was spotted by staff of the Leisure and Cultural Services Department today at Silver Mine Bay Beach, Lantau Island.

The red tide still persists. No associated death of fish has been reported.

A spokesman for the working group said, "The red tide was formed by Takayama tuberculata, which is not commonly found in Hong Kong waters and non-toxic."

The Agriculture, Fisheries and Conservation Department (AFCD) urged mariculturists at Ma Wan and Cheung Sha Wan fish culture zones to monitor the situation closely and increase aeration where necessary.

Red tide is a natural phenomenon. The AFCD's proactive phytoplankton monitoring programme will continue monitoring red tide occurrences to minimise the impact on the mariculture industry and the public.

Transcript of remarks by SLW on Community Care Fund

Following is the transcript of remarks by the Secretary for Labour and Welfare and Chairperson of the Community Care Fund Task Force under the Commission on Poverty, Dr Law Chi-kwong, on the Modular Social Housing Scheme — Nam Cheong Street after chairing a meeting of the Task Force this afternoon (June 1):

Reporter: The cost of this modular housing is relatively high, so how is the Government going to ensure that it is going to accommodate people in need? And as the suggested funding is now passed, does the Government have any other plans to do so that less people would be waiting for public housing?

Secretary for Labour and Welfare: Let me answer your questions. I can't answer really directly, very specifically, but somehow this modular housing is something — although it is not really new in Hong Kong, for the government bureaux and departments, it is the first time participating in these processes. So, we really need to set up a pilot programme to try out all those things, including the rules and procedures, the guidelines and things

like that for this kind of modular housing to be acceptable and secure housing for people in Hong Kong.

This pilot programme will help the Government to consider whether this kind of modular housing can be built more or in a much larger scale in the future if needed. We are optimistic and therefore we, from the Community Care Fund's point of view, support this pilot programme. Hopefully that would provide information for the future consideration for the Government.

Hong Kong Customs seizes suspected methamphetamine (with photo)

Hong Kong Customs yesterday (May 31) seized about 970 grams of suspected methamphetamine with an estimated market value of about \$520,000 at Lok Ma Chau Control Point.

Customs officers conducted Customs clearance on an incoming male passenger at Lok Ma Chau Control Point yesterday evening and found the suspected methamphetamine inside a paper bag carried by him. The 16-year-old man was then arrested.

Investigation is ongoing.

Under the Dangerous Drugs Ordinance, trafficking in a dangerous drugs is a serious offence. The maximum penalty upon conviction is a fine of \$5 million and life imprisonment.
