

CSB officer tests positive for COVID-19

The Civil Service Bureau (CSB) today (March 6) said that a staff member of the CSB has tested positive for COVID-19.

The officer is the Press Secretary to the Secretary for the Civil Service. She usually works in the office and she wore masks and followed relevant disease prevention measures at work. She has no recent travel history. She last went to work on March 4.

The Secretary for the Civil Service, Mr Patrick Nip, has been taking COVID-19 rapid tests every day and the results are all negative.

The CSB will conduct a thorough cleaning and disinfection at the relevant offices and arrange relevant staff members to undergo COVID-19 tests in accordance with the advice from the Centre for Health Protection of the Department of Health.

Government makes “restriction-testing declaration” and issues compulsory testing notice in respect of specified “restricted area” in Hong Ching House, Kai Ching Estate, Kowloon City

The Government today (March 6) exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration" effective from 4.30pm, under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Kowloon City (i.e. Hong Ching House, Kai Ching Estate, Kowloon City, excluding the car park thereat, shops on G/F, podium level and Kai Ching Estate Property Services Management Office. See Annex) are required to stay in their premises and undergo compulsory testing. Persons subject to compulsory testing are required to stay in their premises until all such persons identified in the "restricted area" have undergone testing and the test results are mostly ascertained. The Government aims at finishing this exercise at about 1pm tomorrow (March 7). The operation may be extended depending on test results.

A Government spokesman said, "Under Cap. 599J, the Government can, according to the needs of infection control, make a 'restriction-testing declaration'. As the sewage discharged from the above building was tested positive for COVID-19, it is suspected that there are asymptomatic patients in the building. Given the risk of infection in the relevant area is assessed to be likely higher, the Government decided to make a 'restriction-testing declaration' for the relevant area."

The Government will set up temporary specimen collection stations at the "restricted area" and request persons subject to compulsory testing to undergo testing before 10pm today. Arrangements will be made for persons subject to compulsory testing to undergo a nucleic acid test at specimen collection stations where dedicated staff will collect samples through combined nasal and throat swabs. Persons subject to compulsory testing must stay at their place of residence until all test results are ascertained to avoid cross-infection risk. The Government will make arrangement to facilitate specimen collection for people with impaired mobility.

The Government spokesman said, "We understand that this exercise will cause inconvenience to the public. The Government has made arrangements to carry out testing for all persons present in the 'restricted area' as soon as possible. The aim is to strive to complete testing of all identified persons subject to compulsory testing and confirm the results, and finish the exercise at around 1pm tomorrow. The Government will make a public announcement when the declaration expires officially. In the cases in which employees are unable to go to work because of the declaration, the Government hopes their employers can exercise discretion and not deduct the salaries or benefits of the employees."

If staying in the "restricted area" will cause unreasonable hardship to individuals who are not residents in the area when the declaration takes effect, government officers may exercise discretion and allow that person to leave the area after considering the individual circumstances. That person must have followed the instructions to undergo testing and leave his/her personal information for contact purposes.

According to the compulsory testing notice to be issued today, any person who had been present at the above building for more than two hours from February 21 to March 6, 2022, even if they were not present in the "restricted area" at the time when the declaration took effect, must undergo compulsory testing on or before March 8, 2022. As a mutant strain is involved, for prudence's sake, vaccinated persons and persons who have recently been tested are also required to undergo testing.

The Government appeals to persons subject to compulsory testing for their full co-operation by registering and undergoing testing, and waiting for the results patiently at home. The Government will strictly follow up on whether the persons concerned have complied with the compulsory testing notices and "restriction-testing declaration". Any person who fails to comply with the compulsory testing notices commits an offence and may be fined a fixed penalty of \$10,000. The person would also be issued with a compulsory testing order requiring him or her to undergo testing within a specified time

frame. Failure to comply with the compulsory testing order or the "restriction-testing declaration" is an offence and the offender would be liable to a fine at level 4 (\$25,000) and imprisonment for six months.

Government makes "restriction-testing declaration" and issues compulsory testing notice in respect of specified "restricted area" in Long Shin Estate, Yuen Long

The Government today (March 6) exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration" (declaration) effective from 4pm, under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Yuen Long (i.e. Shin Oi House, Shin Yung House and Shin Leung House, Long Shin Estate, Yuen Long, New Territories, excluding unit 1 on G/F of Shin Oi House, see Annexes) are required to stay in their premises and undergo compulsory testing. Persons subject to compulsory testing are required to stay in their premises until all such persons identified in the "restricted area" have undergone testing and the test results are mostly ascertained. The Government aims at finishing this exercise at about noon tomorrow (March 7). The operation may be extended depending on test results.

“restriction-testing declaration” in respect of specified “restricted area” in Shek Lei (I) Estate, Kwai Chung, and enforcement operation for breaches of compulsory testing notice

The Government yesterday (March 5) exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration" with effect from 4pm yesterday, under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Kwai Chung (i.e. Shek Tai House, Shek Lei (I) Estate, Kwai Chung, excluding Yan Chai Hospital Tung Pak Ying Kindergarten/Child Care Centre on G/F) were required to stay in their premises and undergo compulsory testing. Persons subject to compulsory testing were required to stay in their premises until all such persons identified in the "restricted area" had undergone testing and the test results were mostly ascertained.

In addition, the Government issued a compulsory testing notice yesterday, requiring any person who had been present at the above building for more than two hours from February 20 to March 5, 2022, even if they were not present in the "restricted area" at the time when the declaration took effect, must undergo compulsory testing on or before March 7, 2022.

The Government finished the compulsory testing exercise at around 11.30am today (March 6) and carried out enforcement action in the "restricted area" afterwards to verify that all people in the "restricted area" had undergone compulsory testing in accordance with the requirements of the relevant declaration and compulsory testing notice. The Government announced that the enforcement operation ended at around 1pm today.

The Government delivered food packs to persons subject to compulsory testing to facilitate their meal arrangements. Anti-epidemic proprietary Chinese medicines supplied by the Central People's Government and rapid test kits were also provided to persons subject to compulsory testing to help them fight against the virus. The Housing Department set up a hotline for people restricted by the declaration to make enquiries and seek assistance.

The Government thanks persons subject to compulsory testing for their support and understanding. With everyone's co-operation and efforts, coupled with the tireless efforts of the testing contractors, residents have been informed about their testing results by SMS notification. After finishing the compulsory testing exercise at around 11.30am today, the Government took enforcement action in the "restricted area" immediately to verify that all people in the "restricted area" had undergone testing according to the requirements of the declaration and the compulsory testing notice. Persons

who could present an SMS notification containing a negative test result as proof of having undergone the compulsory testing could leave the "restricted area" through the designated exit after providing personal information to a prescribed officer. The enforcement operation was completed at around 1pm. Test records of about 120 persons subject to compulsory testing were checked. Nobody was found to have not undergone compulsory testing. Taking into account the above situation, the Secretary for Food and Health revoked the "restriction-testing declaration" in accordance with Cap. 599J (see attachment).

The Government reminded the households who have not answered the door to contact the Government for arrangement of testing as soon as possible after reading the notices put up by the Government, in the hope of eliminating the possible risk of further spread of the virus in the community.

The Government thanks all participating government staff and the testing agencies for their hard work. The Government is also grateful to those subject to compulsory testing for their support and understanding, and their full co-operation during this period in undergoing testing and waiting for the results at home.

Moreover, the Government issued a compulsory testing notice yesterday, requiring persons who had been present at the above building for more than two hours from February 20 to March 5, 2022, even if they were not present in the "restricted area" at the time when the declaration took effect, to undergo compulsory testing on or before March 7, 2022. The Government announced the completion of the compulsory testing exercise at around 12.30pm today (March 6) and carried out enforcement action in the "restricted area" afterwards to verify that all people in the "restricted area" had undergone compulsory testing in accordance with the requirements of the relevant declaration and compulsory testing notice. The Government announced that the enforcement operation ended at around 2pm today.
