Government finishes exercise on "restriction-testing declaration" in respect of specified "restricted area" in Tak Yu House, Tak Long Estate, Kowloon City, and enforcement operation for breaches of compulsory testing notice (with photo)

The Government yesterday (March 5) exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration" effective from 1pm that day, under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Kowloon City (i.e. Tak Yu House, Tak Long Estate, Kowloon City) were required to stay in their premises and undergo compulsory testing. Persons subject to compulsory testing were required to stay in their premises until all such persons identified in the "restricted area" had undergone testing and the test results were mostly ascertained.

Moreover, the Government issued a compulsory testing notice yesterday, requiring persons who had been present at the above building for more than two hours from February 20 to March 5, 2022, even if they were not present in the "restricted area" at the time when the declaration took effect, to undergo compulsory testing on or before March 7, 2022. The Government announced the completion of the compulsory testing exercise at around 10am today (March 6) and carried out enforcement action in the "restricted area" afterwards to verify that all people in the "restricted area" had undergone compulsory testing in accordance with the requirements of the relevant declaration and compulsory testing notice. The Government announced that the enforcement operation ended at around noon today.

The Government provided food packs for persons subject to compulsory testing, so as to facilitate the meal arrangements of some persons subject to compulsory testing. Anti-epidemic proprietary Chinese medicines supplied by the Central People's Government and rapid test kits were also provided to persons subject to compulsory testing to help them fight against the virus.

The Home Affairs Department also set up a hotline for people restricted by the declaration to make enquiries and seek assistance.

The Government thanks persons subject to compulsory testing for their support and understanding. With everyone's co-operation and efforts, coupled with the tireless efforts of the testing contractors, residents have been informed about their testing results by SMS notification. After finishing the compulsory testing exercise at around 10am today, the Government took enforcement action in the "restricted area" immediately to verify that all people in the "restricted area" had undergone testing according to the requirements of the declaration and the compulsory testing notice. Persons who could present an SMS notification containing a negative testing result or wore a wristband as proof of having undergone the compulsory testing could leave the "restricted area" through the designated exit after providing personal information to a prescribed officer. The enforcement operation was completed at around noon. Test records of around 300 persons subject to compulsory testing were checked. Forty-three persons were found not having undergone compulsory testing and compulsory testing orders were issued to them. Taking into account the above situation, the Secretary for Food and Health revoked the "restriction-testing declaration" in accordance with Cap. 599J (see attachment).

The Government reminds the about 150 households who have not answered the door to contact the Government for arrangement of testing as soon as possible after reading the notices put up by the Government, in the hope of eliminating the possible risk of further spread of the virus in the community.

The Government thanks all participating government staff and the testing agencies for their hard work. The Government is also grateful to those subject to compulsory testing for their support and understanding, and their full co-operation during this period in undergoing testing and waiting for the results at home.

The Government will seriously follow up on the compliance situation of the compulsory testing notices and the "restriction-testing declaration" by persons subject to compulsory testing. Any person who fails to comply with the compulsory testing notices commits an offence and may be liable to a fixed penalty of \$10,000. The person will also be issued with a compulsory testing order, requiring him or her to undergo testing within a specified time frame. ## <u>Government enforces "restriction-</u> <u>testing declaration" and compulsory</u> <u>testing notice in respect of specified</u> <u>"restricted area" in Aberdeen</u>

The Government yesterday (March 5) exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration" effective from 6.30pm yesterday, under which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in Aberdeen (i.e. Hoi Shan Court and Hoi Wu Court, Aberdeen Centre, excluding the car park and shopping arcade thereat) were required to stay in their premises and undergo compulsory testing. Persons subject to compulsory testing are required to stay in their premises until all such persons identified in the "restricted area" have undergone testing and the test results are mostly ascertained. In addition, the Government issued a compulsory testing notice yesterday to any person who had been present at the building for more than two hours from February 20 to March 5, 2022, to undergo compulsory testing on or before March 7, 2022, even if they were not present in the "restricted area" at the time when the declaration took effect. The Government finished the compulsory testing exercise at around 1pm today (March 6) and is now carrying out enforcement actions in the "restricted area" to verify that all people in the "restricted area" have undergone compulsory testing. The Government will further announce the revocation time of the declaration.

Starting from around 1pm today, persons in the specified "restricted area" in Aberdeen who have undergone testing and are able to present SMS notifications with negative test results or wear wristbands as proof of having undergone testing may leave the "restricted area" through the designated exit after providing personal information to a prescribed officer.

The Government set up temporary specimen collection stations in the "restricted area" yesterday and requested persons subject to compulsory testing to collect combined nasal and throat swab samples at the stations to undergo a COVID-19 virus test before 11pm yesterday. A total of 759 people within the "restricted area" had undergone testing, among which 47 cases tested preliminarily positive were found. The Centre for Health Protection of the Department of Health will arrange to follow up.

Regarding cases tested preliminarily positive in the specified "restricted area", the Government has provided additional food packs, health advice for persons tested preliminarily positive pending admission to hospitals or isolation facilities, disinfection products and surgical masks to these persons and their household members pending follow-up arrangement.

Moreover, the Government also assigned staff to visit 308 households, among which 19 households did not answer the door. The Government will take measures to follow up.

The Government reiterates that enforcement actions will be taken seriously. Any person who fails to present an SMS notification with a test result or wear a wristband as proof of having undergone testing breaches the compulsory testing notice and may be liable to a fine of \$10,000. The person will also be issued with a compulsory testing order, requiring him/her to undergo testing within a specified time frame. Failure to comply with the compulsory testing order or the "restriction-testing declaration" is an offence and the offender may be liable to a fine of level 4 (\$25,000) and imprisonment for six months.

Persons subject to compulsory testing are required to stay in their premises until all such persons identified in the "restricted area" have undergone testing and the test results are mostly ascertained.

In addition, the Government issued a compulsory testing notice yesterday, requiring any person who had been present at the above building for more than two hours from February 20 to March 5, 2022, even if they were not present in the "restricted area" at the time when the declaration took effect, must undergo compulsory testing on or before March 7, 2022. The Government finished the compulsory testing exercise at around 9.30am today (March 6) and carried out enforcement action in the "restricted area" afterwards to verify that all people in the "restricted area" had undergone compulsory testing in accordance with the requirements of the relevant declaration and compulsory testing notice. The Government announced that the enforcement operation ended at around 11.30am today.

The Government spokesman said, "We understand that this exercise will cause inconvenience to the public. The Government has made arrangements to

carry out testing for all persons present in the 'restricted area' as soon as possible. The aim is to strive to complete testing of all identified persons subject to compulsory testing and confirm the results, and finish the exercise at around noon tomorrow. The Government will make a public announcement when the declaration expires officially. In the cases in which employees are unable to go to work because of the declaration, the Government hopes their employers can exercise discretion and not deduct the salaries or benefits of the employees."

If staying in the "restricted area" will cause unreasonable hardship to individuals who are not residents in the area when the declaration takes effect, government officers may exercise discretion and allow that person to leave the area after considering the individual circumstances. That person must have followed the instructions to undergo testing and leave his/her personal information for contact purposes.
