

## **FEHD and Police raid unlicensed barbeque sites at Kau Wa Keng**

The Food and Environmental Hygiene Department (FEHD) conducted a joint blitz operation with the Police last night (March 26) against barbeque sites involving in operating unlicensed food premises at Kau Wa Keng, Kwai Tsing District. Stringent enforcement actions on the requirements and directions under the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Cap. 599F) (the Regulation) were also taken.

During the operation, the FEHD arrested two persons and initiated procedures on prosecution for operating unlicensed food premises in two barbeque sites, and seized relevant paraphernalia and 83 kilogrammes of barbeque food. Since January this year, the FEHD has initiated 11 prosecutions (including six arrests) against operators of barbeque sites involving in unlicensed food premises.

In addition, the FEHD also initiated procedures on prosecution against one barbeque site operator at Kau Wa Keng under the Regulation, relating to no more than four persons may be seated together at one table. Besides, the Police also issued Fixed Penalty Notices to 32 barbeque sites customers for violating the Prevention and Control of Disease (Prohibition on Group Gathering) Regulation (Cap. 599G) on group gathering. A spokesman for the FEHD said, "The department will continue to take stringent enforcement actions against unlicensed food premises. According to the Food Business Regulation (Cap. 132X), anyone operating an unlicensed food business commits an offence and is liable on conviction to a maximum fine of \$50,000 and imprisonment for six months. A maximum fine of \$50,000 and imprisonment for six months, upon conviction, may also be imposed on catering premises operators for violating the Regulation."

The spokesman stressed that the FEHD will continue to step up inspections at food business premises across the territory and conduct joint operations with the Police when necessary to ensure that food business operators and members of the public strictly comply with relevant regulations. Stringent enforcement actions will be taken against offenders to minimise the risk of transmission of COVID-19 in catering business premises.

## **CHP investigates six additional**

# confirmed cases of COVID-19

The Centre for Health Protection (CHP) of the Department of Health (DH) announced that as of 0.00am, March 27, the CHP was investigating six additional confirmed cases of coronavirus disease 2019 (COVID-19), taking the number of cases to 11 446 in Hong Kong so far (comprising 11 445 confirmed cases and one probable case).

Among the newly reported cases announced, all are imported cases.

A total of 229 cases have been recorded in the past 14 days (March 13 to 26), including 153 local cases of which 33 are from unknown sources.

The CHP's epidemiological investigations and relevant contact tracing on the confirmed cases are ongoing. For case details and contact tracing information, please see the Annex or the list of buildings with confirmed cases of COVID-19 in the past 14 days and the latest local situation of COVID-19 available on the website "COVID-19 Thematic Website" ([www.coronavirus.gov.hk](http://www.coronavirus.gov.hk)).

Meanwhile, the CHP reminded those who had visited specified venues under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to receive COVID-19 nucleic acid testing according to the compulsory testing notice. The Regulation also requires all household members of close contacts of confirmed cases to undergo a COVID-19 nucleic acid test within a specified period according to compulsory testing notices published in the Gazette. The public are also urged to seek medical attention early if symptoms develop and undergo testing as soon as possible.

The Government has launched the COVID-19 Vaccination Programme. Members of the public are encouraged to get vaccinated. Details of the programme can be found at the designated website ([www.covidvaccine.gov.hk](http://www.covidvaccine.gov.hk)).

The CHP called on members of the public to avoid going out, having social contact and dining out. They should put on a surgical mask and maintain stringent hand hygiene when they need to go out. The CHP strongly urged the elderly to stay home as far as possible and avoid going out. They should consider asking their family and friends to help with everyday tasks such as shopping for basic necessities.

The spokesman said, "Given that the situation of COVID-19 infection remains severe and that there is a continuous increase in the number of cases reported around the world, members of the public are strongly urged to avoid all non-essential travel outside Hong Kong.

"The CHP also strongly urges the public to maintain at all times strict personal and environmental hygiene, which is key to personal protection against infection and prevention of the spread of the disease in the community. On a personal level, members of the public should wear a surgical

mask when having respiratory symptoms, taking public transport or staying in crowded places. They should also perform hand hygiene frequently, especially before touching the mouth, nose or eyes.

"As for household environmental hygiene, members of the public are advised to maintain drainage pipes properly and regularly pour water into drain outlets (U-traps). After using the toilet, they should put the toilet lid down before flushing to avoid spreading germs."

Moreover, the Government has launched the website "COVID-19 Thematic Website" ([www.coronavirus.gov.hk](http://www.coronavirus.gov.hk)) for announcing the latest updates on various news on COVID-19 infection and health advice to help the public understand the latest updates. Members of the public may also gain access to information via the COVID-19 WhatsApp Helpline launched by the Office of the Government Chief Information Officer. Simply by saving 9617 1823 in their phone contacts or clicking the link [wa.me/85296171823?text=hi](https://wa.me/85296171823?text=hi), they will be able to obtain information on COVID-19 as well as the "StayHomeSafe" mobile app and wristband via WhatsApp.

To prevent pneumonia and respiratory tract infections, members of the public should always maintain good personal and environmental hygiene. They are advised to:

- Wear a surgical mask when taking public transport or staying in crowded places. It is important to wear a mask properly, including performing hand hygiene before wearing and after removing a mask;
  - Perform hand hygiene frequently, especially before touching the mouth, nose or eyes, after touching public installations such as handrails or doorknobs, or when hands are contaminated by respiratory secretions after coughing or sneezing;
  - Maintain drainage pipes properly and regularly (about once a week) pour about half a litre of water into each drain outlet (U-trap) to ensure environmental hygiene;
  - After using the toilet, put the toilet lid down before flushing to avoid spreading germs;
  - Wash hands with liquid soap and water, and rub for at least 20 seconds. Then rinse with water and dry with a disposable paper towel. If hand washing facilities are not available, or when hands are not visibly soiled, performing hand hygiene with 70 to 80 per cent alcohol-based handrub is an effective alternative;
  - Cover your mouth and nose with tissue paper when sneezing or coughing. Dispose of soiled tissues into a lidded rubbish bin, then wash hands thoroughly; and
  - When having respiratory symptoms, wear a surgical mask, refrain from work or attending class at school, avoid going to crowded places and seek medical advice promptly.

## **Application period for Food Courts Subsidy Scheme to end on March 31**

A spokesman for the Food and Environmental Hygiene Department (FEHD) today (March 27) said that the application period for the Food Courts Subsidy Scheme under the fourth round of the Anti-epidemic Fund (AEF) will end at 5pm on March 31 (Wednesday). Operators of eligible licensed food factories in operation, who are interested in the Scheme, are reminded to submit their applications before the deadline.

The spokesman said, "The Scheme opened for application since March 1 and as of March 25, over 370 applications for the Scheme have been received, among which 20 applications have been approved with a sum of \$570,000 disbursed. The FEHD will process the applications as soon as possible so as to provide assistance to eligible licence holders promptly,"

The application form and guidelines can be obtained from District Environmental Hygiene Offices of the FEHD or downloaded from the website of the FEHD ([www.fehd.gov.hk](http://www.fehd.gov.hk)). Eligible food factory licence holders should submit their applications to the District Environmental Hygiene Offices of the FEHD in person or by mail. Upon receipt of the completed application form and supporting documents and after verification, the FEHD will disburse the subsidy in approximately two weeks by mailing crossed cheques to the corresponding licensed food premises.
