# <u>CEDD continues to suspend some public</u> services

In light of the latest developments of the COVID-19 epidemic, the Civil Engineering and Development Department (CEDD) announced today (July 23) that the following public services will continue to be suspended until further notice:

- the Civil Engineering Library;
- (2) in-person applications for dumping licences and sand removal permits; and
- (3) the Permit and Licensing Office of the Mines Division.

The CEDD will closely monitor the epidemic situation and review the arrangements in due course.

#### A police officer preliminarily tested

### positive for COVID-19

A 36-year-old male police officer who is posted to Traffic, New Territories South was preliminarily tested positive for the Coronavirus Disease (COVID-19). The police officer felt unwell on July 21 and sought medical treatment at a hospital the following day (July 22). Preliminary results released yesterday evening showed that he was tested positive for COVID-19. The police officer had no travel history over the past 14 days. He last attended work on July 20, and he wore masks when he had to come into contact with members of the public.

Police are highly concerned about the case and have the following message for members of the public:

- 1) While awaiting further assessment and recommendation by the Department of Health (DH), officers that might have come into close contact with the police officer have been arranged to work from home and undergo tests for the virus;
- 2) Police have deployed staff to clean and disinfect the Disciplined Services Quarters the police officer resides in, as well as the office he works in:
- 3) Police have reminded officers to reduce social contact to minimise risks of infection, and pay attention to physical health. If feeling unwell, they should consult a doctor and report the case.

Police will continue to maintain close communication with DH and proactively provide information such as the recent duty record and roster of the police officer concerned. Arrangements will be made for close contacts to be conveyed to quarantine centres to undergo quarantine.

### Illegal worker jailed

A Nepali illegal worker holding a recognisance form was jailed by Shatin Magistrates' Courts yesterday (July 22).

During an anti-illegal worker operation conducted on June 8, Immigration Department (ImmD) investigators raided a restaurant in Tsuen Wan. A male Nepali illegal worker, aged 36, was arrested while working as a dish-washing worker. Upon identity checking, he produced for inspection a recognisance form issued by the ImmD, which prohibits him from taking employment. Further investigation revealed that he was a non-refoulement claimant. An employer suspected of employing the illegal worker was also arrested and the

investigation is ongoing.

The illegal worker was charged at Shatin Magistrates' Courts yesterday with taking employment after landing in Hong Kong unlawfully and remaining in Hong Kong without the authority of the Director of Immigration or while being a person in respect of whom a removal order or deportation order was in force. He pleaded guilty to the charge and was sentenced to 15 months' imprisonment.

The ImmD spokesman warned that, as stipulated in section 38AA of the Immigration Ordinance, illegal immigrants or people who are the subject of a removal order or a deportation order are prohibited from taking any employment, whether paid or unpaid, or establishing or joining in any business. Offenders are liable upon conviction to a maximum fine of \$50,000 and up to three years' imprisonment. The Court of Appeal has issued a guideline ruling that a sentence of 15 months' imprisonment should be applied in such cases.

The spokesman reiterated that it is a serious offence to employ people who are not lawfully employable. The maximum penalty is imprisonment for three years and a fine of \$350,000. The High Court has laid down sentencing guidelines that the employer of an illegal worker should be given an immediate custodial sentence. According to the court sentencing, employers must take all practicable steps to determine whether a person is lawfully employable prior to employment. Apart from inspecting a prospective employee's identity card, the employer has the explicit duty to make enquiries regarding the person and ensure that the answers would not cast any reasonable doubt concerning the lawful employability of the person. The court will not accept failure to do so as a defence in proceedings. It is also an offence if an employer fails to inspect the job seeker's valid travel document if the job seeker does not have a Hong Kong permanent identity card. The maximum penalty for failing to inspect such a document is imprisonment for one year and a fine of \$150,000.

Under the existing mechanism, the ImmD will, as a standard procedure, conduct an initial screening on vulnerable persons, including illegal workers, illegal immigrants, sex workers and foreign domestic helpers who are arrested during any operation, with a view to ascertaining whether they are trafficking in persons (TIP) victims. When any TIP indicator is revealed in the initial screening, the officers will conduct a full debriefing and identification by using a standardised checklist to ascertain the presence of TIP elements, such as threats and coercion in the recruitment phase and the nature of exploitation. Identified TIP victims will be provided with various forms of support and assistance, including urgent intervention, medical services, counselling, shelter, temporary accommodation and other supporting services. The ImmD calls on TIP victims to report crimes to the relevant departments.
