# Application for Student Grant for 2019/20 school year to close at end of this month

A spokesman for the Education Bureau (EDB) today (June 12) said that in light of the earlier class suspension and gradual class resumption in phases since the end of May, the deadline for application for the Student Grant of \$3,500 for secondary day-school, primary school and kindergarten students in the 2019/20 school year has been extended to June 30, with a view to providing more time for parents to submit applications.

The spokesman appealed to parents and schools that if they have not yet submitted applications to the EDB, they should return the application forms as soon as possible before the deadline.

As regards the overall progress of disbursement of the Student Grant, the spokesman said that payment had already been made to over 80 per cent of the applications. The EDB has been following up with some of the applicants for rectification of incorrect or incomplete information on their application forms.

He said, "To date, we have received a total of about 867 000 applications, among which about 724 000 parents of eligible students have already received the grant. As for the remaining cases, they are mainly with incorrect or incomplete information (e.g. inaccurate bank account number). We are now actively following up with the schools and parents concerned."

The EDB has issued emails to the parents concerned to inform them of their application status. Computer-generated copies of the application details in question will be sent to parents through schools in batches for

parents to amend or provide the information as required. The EDB appeals to the parents concerned to return the amended or supplementary information to the schools as soon as possible so that the EDB could further expedite processing the applications.

A notice of objection should describe the objector's interest and the manner in which he or she alleges that he or she will be affected by the works or the use. ## **Qualified person prohibited by disciplinary board from certifying prescribed inspection and repair of windows for eight months**

The Registered Contractors' Disciplinary Board has completed a disciplinary inquiry under the Buildings Ordinance (BO) and decided that a registered minor works contractor (RMWC) appointed as a qualified person (QP) under the Mandatory Window Inspection Scheme should be disciplined for failing to discharge the duties, or abide by the requirements imposed on a QP under the BO.

The Board ordered the RMWC to be prohibited from certifying any prescribed inspection, or certifying or supervising any prescribed repair in respect of a window in a building for eight months, with effect from the date of the Gazette. The contractor should pay about \$64,000, being the costs of the Board and the Buildings Department (BD) for conducting the inquiry.

The RMWC submitted a certificate to the BD in March 2015, certifying the prescribed inspection and repair had been carried out to all the windows in the common parts of a building in Mong Kok and that the windows had been rendered safe after completion of the prescribed repair.

Subsequently, the BD received a report in respect of a fallen window incident in the subject building. The investigation revealed that a window at the lift lobby on 6/F had fallen to the street and that the RMWC had neither carried out the prescribed inspection nor prescribed the repair in respect of the concerned window and hence failed to discharge the duties, or abide by the requirements imposed on a QP under sections 30E(4) and (5) of the BO.

In view of the investigation result, the BD notified the Board for

consideration of disciplinary action against the RMWC under the provision of section 13(1) of the B0.

A spokesperson for the BD reiterated that in order to ensure building safety, the BD attaches great importance to the quality of the prescribed inspection and repair of windows by a QP. Any QP who contravenes the relevant provisions of the B0 in carrying out the prescribed inspection and repair of windows under the Mandatory Window Inspection Scheme is subject to the BD's enforcement action under the B0.
