<u>June 2019 adjustment in ceiling prices</u> <u>for dedicated LPG filling stations</u>

 $\hat{a} \in \langle \text{The Electrical and Mechanical Services Department today (May 23)}$ announced an adjustment to the auto-LPG (liquefied petroleum gas) ceiling prices for dedicated LPG filling stations from June 1 to June 30, 2019, in accordance with the terms and conditions of the contracts of the dedicated LPG filling stations.

A department spokesman said that the adjustment on June 1, 2019, reflects the movement of the LPG international price in May 2019. The adjusted auto-LPG ceiling prices for dedicated LPG filling stations will range from \$3.37 to \$3.91 per litre, representing no change or a decrease of \$0.01 per litre.

The spokesman said that the auto-LPG ceiling prices were adjusted according to a specified pricing formula. The formula comprises two elements – the LPG international price and the LPG operating price. The LPG international price is the LPG international price of the preceding month. The LPG operating price is adjusted on the first day of February every year according to the movement in the Composite Consumer Price Index in the previous year.

<u>May 31 deadline for proposals to alter</u> <u>rateable values</u>

The Rating and Valuation Department (RVD) today (May 23) reminded the public that proposals to alter the rateable value of properties from April 1 this year must be served on the Commissioner of Rating and Valuation by May 31. Proposals served after May 31 will not be accepted.

Proposals should be made on the specified form (R20A) and be delivered by post or in person. The public can also lodge proposals on an electronic form (e-R20A) using the Electronic Submission of Form service provided on the department's website. Proposals sent by fax are not acceptable. Notwithstanding the lodging of a proposal, rates and rent payers must pay rates and government rent by the last day for payment shown on the demand notes. The RVD will inform the proposers of its decisions before December 1. Any changes in rates and government rent payable resulting from such decisions will date back to April 1 this year and any overpayment will be adjusted in subsequent demands.
