## Press release: £1.5 billion space export campaign to fuel British industry growth

The 'Space Exports' campaign will see 2 of the world's fastest growing markets targeted with trade missions, led by newly appointed Her Majesty's Trade Commissioner Antony Philipson. In India the Department for International Trade (DIT) will also increase its operation by recruiting British space sector experts to work in market.

The campaign comes as 40% of the entire globe's small satellites are built in the UK, highlighting the huge capability in country. The International Trade Secretary will use the opportunity of leaving the European Union to make the most of global engagement with a sector that is growing 15 times faster than the rest of the UK economy.

The UK space industry's growth has been quick, doubling in size since 2010, with exports growing to £5 billion in 2014/15, or 36.4% of total income. The campaign will seek to increase the number of nations that are using the specialist products British businesses produce ahead of the UK's departure from the EU.

International Trade Secretary, Dr Liam Fox MP, said:

Our space industry is thriving as years of strong growth has seen the UK secure its reputation as a leading space nation.

To sustain this, we need to be reaching new markets with huge potential like India and the USA. As an international economic department, we'll achieve this through our new space exports programme, which will help meet the ambition of both government and industry to see space exports reach £40 billion by 2030.

With over a third of its business coming through overseas sales, the space sector is a great example of the benefits of seizing global opportunities which in turn create jobs back home.

Her Majesty's Trade Commissioner to North America, Antony Phillipson, said:

The space sector in the US presents tremendous opportunities for high-quality British goods and services. We are both nations with a rich heritage in space technology.

Through the UK government's extensive and expert trade and investment network, British business will be well-placed to make a major contributions to jobs, just as US firms will be in the UK.

Together we can boost jobs and economic growth in both countries.

Graham Peters, Chair of UK Space said:

The UK has a proud history of leveraging its space expertise to become a leader in commercial aspects of space. We are delighted to be working with government to promote UK capabilities overseas to underpin the continued growth of the sector.

Dr Jaime Reed Industry Co-Chair of the Space Growth Partnership's Space Exports Group said:

Industry and DIT have been working closely to build a solid evidence base demonstrating the potential for significant new UK business in major global markets. It's fantastic to see the government committing to growth through these new announcements.

The government is engaging with the sector to determine how best to create a sector deal with them that drives forward the modern Industrial Strategy. Low cost access to space is an important part of this, and there have been significant steps taken this week to enable small satellite launch from UK soil for the first time.

### Case study

The space sector is not the only one that can benefit from expansion into the US and India. The UK's aerospace companies carry a strong reputation around the globe and this has been exemplified by Derby-based Pattonair, who last week announced that they would expand their manufacturing operation to Bangalore.

By opening their factory in Bangalore, Pattonair are aiming to tailor their supply chain services to customers in the region. When the new facility opens it will be the latest in a succession of British based companies in the city, with Airbus and Rolls-Royce also operating there.

# News story: Defence Secretary and Australian Minister tour Scottish site building world-class warships as £1 billion is pumped into supply chain

Australia's decision to choose BAE Systems to build the nine British-designed warships could be worth up to £20 billion, and has been hailed as the biggest Naval ship deal for a decade. The agreement has massive potential benefits across the entire existing Type 26 supply chain, which the Defence Secretary outlined has now seen investment of more than £1 billion across more than 80 companies.

Speaking during the visit to BAE Systems' Clyde Shipyard with Minister Payne today, the Defence Secretary revealed the massive investment had already boosted family firms and British businesses across the nation, showing the importance of shipbuilding in every corner of the country, and its potential to support allies across the world.

Defence Secretary Gavin Williamson said:

This renaissance in British shipbuilding is great news for our major yards, but also for the whole defence industry, with millions being injected into so many businesses, both big and small, supporting and supplying our world-class warships. The Type 26 supply chain has now seen investment worth over £1 billion, and many of the businesses involved are now perfectly placed to benefit from Australia's £20 billion build.

Australian Minister of Defence Ms Payne toured the shipyard where Britain's new warship fleet is being constructed. Her Government's 'Global Combat Ship' agreement, which was announced last month and will see nine of Britain's cutting-edge ships built in Australia, is also expected to draw on the United Kingdom's robust supply chain to support the construction of its fleet.

BAE Systems Chief Executive Charles Woodburn said:

Australia's selection of the Type 26 Combat Ship for its Future Frigates programme reflects the world-leading anti-submarine warfare capabilities these ships will deliver to the UK and to the

### Commonwealth.

In the 12 months since cutting steel on the first of the UK ships, we have committed more than £1 billion with supply chain companies, large and small — vital partners in delivering cutting edge capability to the Royal Navy, supporting thousands of jobs and contributing to national prosperity.

Our recent success on the Australian Future Frigate programme will not only deliver huge benefits for Australia, supporting jobs, local industry and sovereign capability — it will also generate opportunities for companies in our UK supply chain.

The pair's visit to the Govan shippard comes almost exactly a year to the day since the first steel was cut on HMS Glasgow, marking the beginning on the build of Britain's first Type 26 frigate.

More than 80% of the total equipment spend has now be committed to the supply chain, and more than 80 companies have secured contracts to supply material for the first three ships.

Sixty-four of those companies are based across the United Kingdom, supporting more than 4000 jobs. The regional reach of the Type 26 ship helped secure the Australian deal for BAE Systems, with the success stories across Britain expected to be replicated in Australia.

The naval contract, which is the biggest surface ship deal in the past decade and saw the UK chosen ahead of Italian and Spanish firms, is the first time a British ship design has been exported since the 1970s.

The deal will secure more than 4,000 jobs in Australia and boost Britain's export economy for generations to come, opening a raft of opportunities for British firms to offer specialist knowledge and capabilities.

The 6,900 tonne multi-mission warships are designed to support anti-submarine warfare and a whole range of other operations anywhere in the world. They will form a key part of the Royal Australian Navy.

The formidable frigates will also allow interoperability between Australian and Royal Navy ships amid a climate of intensifying threats around the world, especially in the Middle East and the Asia-Pacific regions.

The visit to the Scottish shipyard also came on the day the <u>Defence Secretary</u> announced plans to ensure that thousands of troops resident in Scotland are not left out of pocket following recent tax rises from the Scottish <u>Government</u>.

### Press release: UK Government Ministers support Wales' rural economy at Royal Welsh Show

The Royal Welsh Show is Wales' biggest agriculture event and the UK Government will be there in force — taking this excellent opportunity to engage with the industry, underline the importance of the rural economy to Wales and wider UK and show how determined we are to get a good deal for the sector in our EU exit negotiations.

We need to be bold and ambitious and maximise the opportunities Brexit brings. To achieve this it is vital that the UK and the Welsh Governments work together — as well as with businesses — to ensure our rural economy can continue to grow.

Attracting over 240,000 visitors every year, the show also provides an important platform for show-goers to find out how the UK Government is delivering for people in Wales— including on provisions for childcare, pensions, defence and business start-up support. I look forward to meeting businesses and members of the public over the course of the show, to hear about their priorities over the coming months and years.

The Welsh Secretary will be joined at the Show by Environment Secretary Michael Gove on Tuesday where they will host a reception at the UK Government stand to meet industry leaders, businesses and show-goers.

### appointed to manage Fast Pensions schemes

Fast Pensions Ltd and five other related companies were <u>wound up in the public interest</u> at the High Court on 30 May 2018.

On 5 July Dalriada Trustees Limited (Dalriada) was formally appointed by the Pensions Regulator (TPR) to act as an Independent Trustee to the 15 schemes linked to Fast Pensions Limited.

As Trustee to the schemes, Dalriada is undertaking a detailed analysis of Fast Pensions and will liaise with the Insolvency Service to determine who the members are, as well as understand more about the schemes, how they were operated, how the transferred funds were invested and what the likelihood is of any material recovery of those funds.

It is estimated that around 520 people were encouraged to transfer their pension savings from existing providers into one of 15 schemes and a total of at least £21 million was transferred to the schemes.

Dalriada will issue a communication to members as soon as it is in a positon to do so and will keep members informed thereafter as to developments.
