

## **Statutory guidance: SR2015 No 13:** **75kte vehicle storage depollution and dismantling (authorised treatment) facility**

*Updated:* Added to 'details' section: You can apply online for most standard rules environmental permits.

These standard rules allow you to operate a vehicle depollution and dismantling facility at a specified location, provided that the permitted activities are not carried out within 200 metres of a:

- European Site
- Ramsar site
- Site of Special Scientific Interest

The activities must not be carried out within:

- Groundwater Source Protection Zone 1
- 50m of any well, spring or borehole used for the supply of water for human consumption, including private water supplies

## **Statutory guidance: SR2015 No 14:** **75kte metal recycling site**

*Updated:* Added to 'details' section: You can apply online for most standard rules environmental permits.

These standard rules allow you to operate a metal recycling site at a specified location, provided that the permitted activities are not carried out within:

- 500 metres of a European Site, Ramsar site or Site of Special Scientific Interest
- 50m of any well, spring or borehole used for the supply of water for human consumption, including private water supplies

## **Statutory guidance: SR2015 No 18: metal recycling, vehicle storage, depollution and dismantling facility**

*Updated:* Added to 'details' section: You can apply online for most standard rules environmental permits.

These standard rules allow you to operate a metal recycling site and a vehicle depollution and dismantling facility at a specified location.

These rules will permit the sorting, separation, grading, shearing, baling, compacting, granulating of cables and cutting using hand-held equipment only, of ferrous metals or alloys and non-ferrous metals for recovery as well as the recovery (including storage) of all waste motor vehicles.

The total quantity of waste that can be accepted at a site under these rules must be less than:

- 25,000 tonnes a year of waste metal
- 5,000 tonnes a year of waste motor vehicles

The rules will not permit the burning of any wastes, either in the open, inside buildings or in any form of incinerator.

## **Statutory guidance: SR2015 No 3: metal recycling and WEEE authorised treatment facility excluding ozone**

## depleting substances

*Updated:* Added to 'details' section: You can apply online for most standard rules environmental permits.

These standard rules allow you to operate a metal recycling and waste electrical and electronic equipment (WEEE) authorised treatment facility at a specified location.

The total quantity of waste that can be accepted at a site under these rules must be less than 75,000 tonnes a year. The rules will not permit the treatment of WEEE containing ozone-depleting substances but it can be accepted for storage only.

## Statutory guidance: SR2015 No 11: household, commercial and industrial waste transfer station with treatment and asbestos storage

*Updated:* Added to 'details' section: You can apply online for most standard rules environmental permits.

These standard rules allow you to operate a household, commercial and industrial waste transfer station with waste treatment and asbestos storage at a specified location.

The permitted activities must not be carried out within:

- 500 metres of a European Site, Ramsar Site or Site of Special Scientific Interest
- 50 metres of any well, spring or borehole used for the supply of water for human consumption, including private water supplies
