

# Import of poultry meat and products from Chesterfield County, South Carolina in US and Sułä™ciÅ„ski District of Lubuskie in Poland suspended

The Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department announced today (March 26) that in view of a notification from the World Organisation for Animal Health (OIE) about an outbreak of low pathogenic H7N3 avian influenza in the Chesterfield County of the State of South Carolina in the United States (US) and a notification from the General Veterinary Inspectorate, Poland about an outbreak of highly pathogenic H5N8 avian influenza in the Sułä™ciÅ„ski District of Lubuskie in Poland, the CFS has instructed the trade to suspend the import of poultry meat and products, including poultry eggs, from the above areas with immediate effect to protect public health in Hong Kong.

A CFS spokesman said that Hong Kong imported about 690 tonnes of chilled poultry meat, 257 970 tonnes of frozen poultry meat and 642 million poultry eggs from the US and imported about 17 720 tonnes of frozen poultry meat and 34.26 million poultry eggs from Poland last year, according to the Census and Statistics Department.

"The CFS has contacted the US and Polish authorities over the issues and will closely monitor information issued by the OIE and the relevant authorities on avian influenza outbreaks. Appropriate action will be taken in response to the development of the situation," the spokesman said.

On the retirement of Mr Li Kin-yat, Mr Law said, "Mr Li has served with zeal and commitment in the civil service throughout the past 37 years. As the Director of Fire Services, Mr Li has made sustained efforts in enhancing firefighting and rescue capabilities of the Fire Services Department, and in promoting fire safety in the community as well as providing efficient emergency ambulance services to the public. Brief biographical notes on the four officers are set out below:

Mr Simon Li Tin-chui

Mr Li joined the Civil Aviation Department as Assistant Operations Officer in February 1983 and was promoted to Chief Operations Officer in May 1998. He was promoted to Assistant Director-General of Civil Aviation in August 2010 and to Deputy Director-General of Civil Aviation in April 2015 before being appointed as Director-General of Civil Aviation in May 2016.

Captain Victor Liu Chi-yung

Captain Liu joined the Social Welfare Department as Assistant Social Work Officer in February 1990 and was appointed as Executive Officer II in November 1990. He joined the Civil Aviation Department as Assistant Operations Officer in March 1992 and was promoted to Chief Operations Officer in August 2006. He was promoted to Assistant Director-General of Civil Aviation in July 2011, and was appointed as Deputy Director-General of Civil Aviation in May 2016.

Mr Li Kin-yat

Mr Li joined the Fire Services Department as Station Officer in August 1983 and was promoted to Deputy Chief Fire Officer in May 2009, to Chief Fire Officer in October 2011 and to Deputy Director of Fire Services in December 2014 before being appointed as Director of Fire Services in August 2016.

## Sick person in custody dies in public hospital

A sick 59-year-old male person in custody at Stanley Prison died in a public hospital yesterday (March 25).

The person in custody suffered from diabetes mellitus. He required continuous medical care and follow-up at the institution hospital and a public hospital. In mid-December 2019, he was sent to the public hospital for treatment due to physical discomfort and suspected stroke. During hospitalisation, his condition deteriorated and he was certified dead at 8.45pm yesterday.

The case has been reported to the Police. A death inquest will be held by the Coroner's Court.

The person in custody was sentenced to imprisonment for the offence of trafficking in a dangerous drug in July 2016.
