### CAS holds 79th Recruits Passing-out Parade (with photos)

Mr Chan today presented outstanding recruit awards to one officer cadet and eight recruit members. The CAS members and recruits also demonstrated removal of fallen trees, emergency rescue, and mountain search and rescue skills.

The Assistant Commissioner (Training and Development) of the CAS, Mr Fung Kam-man, said that the CAS recruitment exercise for 2019 has started.
