Chow Fan-fu has hosted a variety of classical music and cultural programmes on Radio Television Hong Kong's Radio 4 since 1982. He is currently Vice-Chairman of the Hong Kong Chapter of the International Association of Theatre Critics and an examiner for the Hong Kong Arts

Development Council. In 2011, he was awarded a Medal of Honour by the Hong Kong Special Administrative Region Government for his continued and tireless efforts in the promotion of classical music and appreciation of the arts. Publications authored by him include "Music Is Life", which was nominated for Ten Best Books of 2006, and "Music with Love: The 30th Anniversary of the Hong Kong Philharmonic Orchestra", which was listed as one of the Ten Best Books of 2005.

<u>Pablo Ziegler Latin Jazz Trio to</u> <u>perform in Hong Kong in October</u>

Grammy Award-winning pianist Pablo Ziegler will collaborate with versatile guitarist Quique Sinesi and remarkable bandoneon player Walter Castro for a Latin jazz performance in Hong Kong in October.

Featuring part of their 2015 release "Desperate Dance", the concert will be staged at 8pm on October 16 (Tuesday) at the Auditorium of Sha Tin Town Hall as one of the programmes of this year's "Jazz Up" series.

Pablo Ziegler graduated from the Buenos Aires Conservatory and debuted as a classical pianist at the age of 14. His playing style, both sharply percussive and metallically lyrical, is instantly recognisable and bears some similarities to that of Vladimir Horowitz as well as some of the wistfulness of Bill Evans' approach. For decades, Ziegler has been one of the most important figures in Argentine new tango, the vibrant musical hybrid of traditional tango, American jazz and European art music. After performing in tango grand-maestro Astor Piazzolla's legendary quintet for over a decade, Ziegler has led his own groups for over 25 years, refining and reimagining the bounds of the modern tango tradition.

Quique Sinesi is one of the most versatile guitarists from Argentina. As a composer for classical guitar, Sinesi has established a great reputation for his insightful, meticulous and virtuosic interpretation of the genre. Walter Castro, who is an integral figure on the tango scene with his remarkable bandoneon playing, shines in ensembles large and small.

While each member is a master in his own right, the trio have together written new arrangements and compositions that have won them an enthusiastic

following who love their incredible talents, and have set new standards in tango nuevo.

The TAC is a key advisory body to the Government on broad issues of transport policy and major transport-related proposals.
