## **54th round of computer ballot registration for submitting applications for Northbound Travel for Hong Kong Vehicles to be open June 2 to 5**

The Transport Department today (June 1) reminded members of the public that the 54th round of computer ballot registration for submitting applications for Northbound Travel for Hong Kong Vehicles (the scheme) will be open from 10am tomorrow (June 2) to 11.59pm on June 5, and the ballot result will be announced on June 6.

Eligible applicants for the scheme can register for computer balloting through the designated website ([www.hzmbqfs.gov.hk](http://www.hzmbqfs.gov.hk)). Successful balloting applicants are required to submit applications for the scheme within the designated application period.

## **Smart devices slash water waste**

The Water Supplies Department has commissioned the University of Hong Kong's Centre for Water Technology and Policy to launch the Water-smart Taskforce Programme that helps people to reduce water wastage with the use of artificial intelligence-powered technology. Due to its success so far, over

80 per cent of the first batch of domestic participants have been able to reduce their water consumption.

## **Red flag hoisted at Ting Kau Beach**

The Leisure and Cultural Services Department announced today (June 1) that according to the Beach Water Quality Forecast System of the Environmental Protection Department ([www.epd.gov.hk/epd/english/environmentinhk/water/beach\\_quality/forecast\\_system.html](http://www.epd.gov.hk/epd/english/environmentinhk/water/beach_quality/forecast_system.html)), the Beach Water Quality Forecast Index for Ting Kau Beach in Tsuen Wan District is 4, which means the predicted water quality at this beach is "Very Poor" due to potential transient water quality fluctuations caused by heavy rain. The red flag has been hoisted, and beachgoers are advised not to enter the water to safeguard their health.
