The Leisure and Cultural Services Department announced today (October 15) that due to big waves and inclement weather, red flags have been hoisted at Shek O Beach and Big Wave Bay Beach in Southern District, Hong Kong Island; and Hap Mun Bay Beach and Clear Water Bay Second Beach in Sai Kung District. Beachgoers are advised not to swim at these beaches.

<u>COVID-19 Vaccination Stations to be</u> <u>set up at four public hospitals</u>

The Government will set up COVID-19 Vaccination Stations in four public hospitals starting from next Monday (October 18) to enable patients visiting the hospital for follow-up appointments and visitors, in particular patients of specialist out-patient clinics, to receive BioNTech vaccination without prior booking when they have their follow-up medical consultation.

The new COVID-19 Vaccination Stations will be set up in Pamela Youde Nethersole Eastern Hospital, Tseung Kwan O Hospital, Caritas Medical Centre and Prince of Wales Hospital respectively. In addition to the vaccination stations in Queen Mary Hospital, Queen Elizabeth Hospital and Tuen Mun Hospital which came into service last month, the number of vaccination stations will increase from three to seven.

The Secretary for the Civil Service, Mr Patrick Nip, said today (October 15), "The vaccination rate for elderly persons has increased recently. However, given the threat posed by mutant strains, their vaccination rate should raise further as they have comparatively higher risk of falling seriously ill and dying brought by COVID-19 infection. As such, the Government set up vaccination stations operated by medical organisations in

three public hospitals as a pilot scheme. In the past two weeks, an average of about 200 people received vaccination at the vaccination stations every day. After evaluation, the Government has decided to expand the scheme to enable more elderly persons to receive vaccination when they have their follow-up medical consultation at specialist out-patient clinics in hospitals."

The vaccination stations operate from 10am to 7pm on weekdays except public holidays, with no lunch break. Last vaccination is at 6.30pm. Arrangements will be made for people being vaccinated to have their second dose injection at the same vaccination station or another Community Vaccination Centre. For those who opt for the Sinovac vaccine, they will be referred to a nearby Community Vaccination Centre.

2021 final register for Rural Representative Election released today

â€<The 2021 final register for the Rural Representative Election (RRE) was released today (October 15). The final register includes particulars of registered electors of Existing Villages, Indigenous Villages and Composite Indigenous Villages and Market Towns. Members of the public may visit the RRE Voter Registration Information Enquiry System through the RRE website (www.had.gov.hk/rre) to check their own registration particulars. They may also call the RRE hotline on 2152 1521 during ordinary business hours to check the above-mentioned information.

A full copy of the final register is placed at the office of the Electoral Registration Officer located at the Home Affairs Department (HAD), 30/F, Southorn Centre, 130 Hennessy Road, Wan Chai, while a copy of the specific divisions of the final register for a rural area that belongs to the rural committees concerned is placed at the offices of the Assistant Electoral Registration Officers in the respective New Territories District Offices. In accordance with the judgment handed down by the Court of Appeal on May 21, 2020, and the order made at the hearing on May 27, 2020 (Case No. CACV 73/2020), validly nominated candidates, members of the press (as with the case of other public elections, the HAD adopts the list of subscribers of the Government News and Media Information System), political parties (i.e. political bodies/organisations which meet the specified requirements), the Heung Yee Kuk, respective Rural Committees for the relevant Rural Areas, indigenous inhabitants of the relevant Indigenous Villages and Composite

Indigenous Villages and residents of the relevant Existing Villages or Market Towns for any purpose relating to an election may inspect the aforementioned final registers of electors during ordinary business hours.

Eligible organisations/persons may make appointments for inspection by calling the RRE hotline during ordinary business hours starting from today. Upon completion of initial reservation by phone, the applicant is required to fill in and return an official reservation form to the HAD by a specified deadline to confirm the reservation.

The ordinary business hours for inspection of the final register are from 9am to 1pm and from 2pm to 6pm, Monday to Friday (except general holidays).
