

## Government completes enforcement action on compulsory testing notice at building in Hung Hom

The Kowloon City District Office together with Kowloon City Police District and the Centre for Health Protection (CHP), conducted an enforcement operation today (February 24) at a building in Hung Hom, which was included in a compulsory testing notice earlier. The operation started at around 7.30am and ended at around 9.50am today.

Starting from around 7.30am today, residents of Sung Oi Building, Shung Tze Houses, 41 Sung Kit Street, Hung Hom, were requested to provide the SMS notification received through a mobile phone or related certification containing the results of COVID-19 tests, to show that they had taken such tests as required pursuant to the compulsory testing notice of the building within the specified period issued by the Government earlier on. The Government arranged for staff to verify the testing certifications of the residents at the entrances/exits of the building, and conducted checks in the building to verify whether residents had undergone testing in compliance with the requirement.

During the operation, test records of 264 residents were checked. Among them, 14 persons were found to have violated the compulsory testing notice. The Government has issued compulsory testing orders and/or fixed penalties of \$5,000 to them, requiring them to undergo testing within a specified period. Non-compliance with a compulsory testing order is an offence, and offenders are liable to a fine of \$25,000 and imprisonment for six months.

The Government reiterates that the aim of issuing a compulsory testing notice is to stop the spread of COVID-19 in the community as soon as possible to protect overall public health and safety. Persons subject to testing under a compulsory testing notice should, as far as reasonably practicable, take appropriate personal disease prevention measures including wearing a mask and maintaining hand hygiene, and, unless for the purpose of undergoing the specified test, stay at their place of residence and avoid going out until the test result is ascertained as far as possible.

The Government wishes to thank the many residents who had complied with the compulsory testing notice for their co-operation to fight against the virus together. The Government will continue to enforce the law strictly. All persons subject to compulsory testing should comply with the compulsory testing notice. Any person who fails to comply with the compulsory testing notice may be liable to a fixed penalty of \$5,000. The person will also be issued with a compulsory testing order, requiring him or her to undergo testing within a specified time frame. Non-compliance with the order is an offence and the offender may be liable to a fine of \$25,000 and imprisonment for six months.

The Kowloon City District Office is grateful for the support and co-operation of the Police and the CHP to enable the enforcement action to be carried out smoothly. The Government understands that the enforcement process may cause some inconvenience to the residents, but hopes that the residents can understand.

## **Sewerage rising main rehabilitation works at Seaview Promenade**

The Drainage Services Department today (February 24) announced that sewerage rising main rehabilitation works will be carried out on February 25 near Deep Water Bay Beach and Repulse Bay Beach in Southern District, Hong Kong Island. The water quality of the nearby waters may potentially be affected. To safeguard public health, members of the public are advised not to swim at the nearby beaches and sea area on that day.

The Leisure and Cultural Services Department announced earlier that in view of the latest developments of COVID-19, all gazetted bathing beaches were temporarily closed from December 10, 2020, until further notice.

# Government enforces “restriction-testing declaration” and compulsory testing notice in respect of specified “restricted area” in San Po Kong

The Government yesterday (February 23) exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) to make a "restriction-testing declaration" effective from 8.30pm yesterday, by which people (hereafter referred to as "persons subject to compulsory testing") within the specified "restricted area" in San Po Kong (i.e. Cambridge Building, 6-24A Kam Wing Street, and Tong Seng Mansion, 1-33 Kam Wing Street and 5-7 Yin Hing Street, San Po Kong) are required to stay in their premises and undergo compulsory testing. Persons subject to compulsory testing are required to stay in their premises until all such persons identified in the area have undergone testing and the test results are mostly ascertained. In addition, the Government had issued a compulsory testing notice yesterday to any person who had been present at the buildings for more than two hours from February 10 to 23, 2021, to undergo compulsory testing before February 25 even if they were not present in the "restricted area" at the time when the declaration took effect. The Government finished the compulsory testing exercise at around 7am today (February 24) and is now carrying out enforcement actions in the "restricted area" to verify that all people in the "restricted area" have undergone compulsory testing. The Government will further announce the revocation time of the declaration.

Starting from around 7am today, persons in the "restricted area" in San Po Kong who have undergone testing in accordance to the requirements of the relevant declaration and compulsory testing notice, as well as are able to present SMS notifications with negative test results or wear wristbands as proof of having undergone testing may leave the "restricted area" through the designated exit after providing personal information to a prescribed officer.

The Government set up temporary specimen collection stations in the "restricted area" yesterday and requested persons subject to compulsory testing to collect combined nasal and throat swab samples at the stations to undergo a COVID-19 virus test before 2am today. As at 2am today, around 520 residents had undergone testing. No confirmed cases were found.

Moreover, the Government also assigned staff to visit 256 households, 56 households did not answer the door. Those include some households with confirmed case or undergoing quarantine. Some units are possibly vacant as well. The Government does not have detailed information in this respect and will take measures to follow up.

The Government also understands that some residents already underwent testing at the mobile specimen collection stations set up in the district or

by other means. Therefore, persons in the "restricted area" who have undergone testing from February 21 to 23, 2021, and are able to provide the SMS notification through mobile phone or related certification containing the test results, are not required to take the test again.

The Government reiterates that enforcement actions will be taken seriously. Any person who fails to present an SMS notification with a negative test result or wear a wristband as proof of having undergone testing breaches the compulsory testing notice and may be liable to a fine of \$5,000. The person will also be issued with a compulsory testing order, requiring him/her to undergo testing within a specified time frame. Failure to comply with the compulsory testing order or the "restriction-testing declaration" is an offence and the offender may be liable to a fine of level 4 (\$25,000) and imprisonment for six months.

## Government gazettes compulsory testing notice

The Government exercised the power under the Prevention and Control of Disease (Compulsory Testing for Certain Persons) Regulation (Cap. 599J) and published in the Gazette a compulsory testing notice, which requires any person who had been present at three specified premises during the specified period (persons subject to compulsory testing) to undergo a COVID-19 nucleic acid test.

Currently, in all districts in Hong Kong, if one or more new confirmed cases are found in the residential buildings (including buildings for both commercial and residential uses), or there are sewage samples tested positive which implied possible infection risks, the buildings will be included in the compulsory testing notice.

For testing targeting at workplaces, if two or more confirmed cases are found in a workplace, it will be included in the compulsory testing notice.

Three buildings fulfilling the above criteria were included in the compulsory testing notice today (February 23).

Details of the compulsory testing notice are as follows:

Any person who had been present at any specified premises listed in Annex 1 for more than two hours at any time during the period from February 10 to February 23, 2021 (including but not limited to visitors, residents and workers), have to undergo testing by February 25, 2021. If persons subject to compulsory testing have previously undergone testing between February 21 and February 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Furthermore, a spokesman for the Food and Health Bureau reminds the public that in accordance with the compulsory testing notice issued earlier, all household members of close contacts are required to undergo compulsory testing. Any person who had lived with a person who is placed under quarantine pursuant to section 22 of the Prevention and Control of Disease Regulation (Cap. 599A) (person under quarantine) in the same residential unit on the date of commencement of quarantine or during the 14 days before that day, and who becomes aware of the quarantine of the person under quarantine when the relevant quarantine has not yet been completed, have to undergo testing within two days of he/she becoming aware of the person under quarantine has been placed under quarantine and report to the Government the result of the test by phone (at 6275 6901), fax (at 2530 5872) or email (ct@csb.gov.hk) within three days of undergoing the test.

The Government will set up mobile specimen collection station at Tsuen Wan Centre tomorrow (February 24) for local residents and workers subject to compulsory testing. The service period of the mobile specimen collection stations at Maple Street Playground in Sham Shui Po, King George V Memorial Park, Kowloon and Arthur Street Temporary Playground in Yau Ma Tei will be extended to February 28 (Sunday). The opening dates and operating hours of the mobile specimen collection stations in various districts providing free COVID-19 nucleic acid testing services for the general public are stated in Annex 2. Apart from mobile specimen collection stations, persons subject to compulsory testing can also choose to attend any of the community testing centres in all districts to receive testing free of charge.

Persons subject to compulsory testing may choose to undergo testing via the following routes:

1. To visit any of the mobile specimen collection stations (see the list and target groups (if applicable) at [www.coronavirus.gov.hk/eng/early-testing.html](http://www.coronavirus.gov.hk/eng/early-testing.html)) for testing;
2. To attend any of the community testing centres (see the list at [www.communitytest.gov.hk/en/](http://www.communitytest.gov.hk/en/));
3. To obtain a deep throat saliva specimen collection pack from any of the 121 post offices, vending machines set up at 20 MTR stations or 47 designated general outpatient clinics (GOPCs) of the Hospital Authority and return the specimen to one of the designated specimen collection points (see the distribution points and times, and the specimen collection points and times, at [www.coronavirus.gov.hk/eng/early-testing.html](http://www.coronavirus.gov.hk/eng/early-testing.html));
4. To undergo testing at any of the GOPCs of the Hospital Authority as instructed by a medical professional of the Hospital Authority;
5. To self-arrange testing provided by private laboratories which are recognised by the Department of Health (DH) and can issue SMS notifications in respect of test results (see the list at [www.coronavirus.gov.hk/pdf/List\\_of\\_recognised\\_laboratories\\_RTPCR.pdf](http://www.coronavirus.gov.hk/pdf/List_of_recognised_laboratories_RTPCR.pdf)); or
6. To use a specimen bottle distributed to the relevant specified premises by the Centre for Health Protection (if applicable), and return the specimen bottle with the sample collected as per relevant guidelines.

The spokesman cautioned that testing received at accident and emergency departments of the Hospital Authority or during hospital stays, or testing

provided by private laboratories which cannot issue SMS notifications in respect of test results, does not comply with the requirements of the aforementioned compulsory testing notice.

"If persons subject to compulsory testing have symptoms, they should seek medical attention immediately and undergo testing as instructed by a medical professional. They should not attend the mobile specimen collection stations or the community testing centres."

Persons subject to compulsory testing must keep the SMS notification containing result of the test for checking by a law enforcement officer when the officer requires the persons to provide information about their undergoing the specified test.

Furthermore, persons subject to testing under the compulsory testing notices should, as far as reasonably practicable, take appropriate personal disease prevention measures including wearing a mask and maintaining hand hygiene, and, unless for the purpose of undergoing the specified test, stay at their place of residence and avoid going out until the test result is ascertained as far as possible.

Any enquiries on compulsory testing arrangements may be addressed to the hotline at 6275 6901, which operates daily from 9am to 6pm. If persons subject to compulsory testing plan to conduct testing at any of the community testing centres, they can check the centre's appointment status in advance. The hotlines of the community testing centres are available at [www.communitytest.gov.hk/en/info/](http://www.communitytest.gov.hk/en/info/).

The Government will continue to trace possibly infected persons who had been to the relevant premises, and seriously verify whether they had complied with the testing notices. Any person who fails to comply with the testing notices commits an offence and may be fined a fixed penalty of \$5,000. The person would also be issued with a compulsory testing order requiring him or her to undergo testing within a specified time frame. Failure to comply with the order is an offence and the offender would be liable to a fine at level 4 (\$25,000) and imprisonment for six months.

Relevant officers of different government departments are empowered to perform certain functions under the relevant Regulations under the Prevention and Control of Disease Ordinance (Cap. 599), including requesting individuals to provide information and assistance when necessary. Any person who fails to comply with the relevant request commits an offence and would be liable to a fine at level 3 (\$10,000). Collection and use of any personal data for conducting COVID-19 tests must meet the requirements under the Personal Data (Privacy) Ordinance (Cap. 486). Government departments or testing service providers which handle the relevant information may provide the data to DH or other relevant departments for anti-epidemic purpose as necessary. The workflow does not involve the provision of any personal data to organisations or persons outside Hong Kong.

The spokesman said, "The Government urges all individuals who are in doubt about their own health conditions, or individuals with infection risks

(such as individuals who visited places with epidemic outbreaks or contacted confirmed cases), to undergo testing promptly for early identification of infected persons."
