Government response: Department for International Development response to Independent Expert Panel report into UNAIDS

Responding to the findings of the Independent Expert Panel report into UNAIDS the Department for International Development said:

“The Independent Expert Panel into UNAIDS highlights how poorly harassment, including sexual harassment, and bullying have been dealt with at the organisation.

“The UK recognises the critical role that UNAIDS as an organisation plays in the global AIDS response. However, it is important that actions urgently needed to address the issues identified within UNAIDS, start immediately. This requires strong leadership that builds trust within the organisation and with UNAIDS’ partners.

“For real change to happen new leadership is required. We welcome the decision by the Programme Coordinating Board (PCB) to initiate the recruitment process for a new Executive Director immediately. In the UK’s remaining two weeks as Chair of the PCB, the UK will work with UNAIDS Secretariat to initiate this process.

“At the same time the UK expects the current Executive Director to step down. This is vital to signal a strong response to this critical issue within and beyond the organisation.

“This report comes amid concerns this year over how the wider global aid community has failed in its duty to protect people from sexual harassment, exploitation, bullying and abuse of power. It is now time that people are held to account.

“The UK has been a driving force in tackling this issue, galvanising the sector to put in place the vital initiatives needed to finally rid it of those who seek to tarnish its reputation. We have been very clear that we will not tolerate practices which do not reach the highest standards in

relation to tackling harassment, including sexual harassment, bullying and abuse of power.”

The London Food Strategy aims to ensure all Londoners have access to healthy, affordable and sustainable food.

The Government Chemist [provided comments to the draft Food Strategy for London](#) document produced by the London Mayor office in July 2018.

The final London Food Strategy has now been published. This is the first Mayoral strategy for food in London since 2006. Food is a key part of the Mayor's social fairness and economic equality agenda and the London Food Strategy aims to ensure all Londoners have access to healthy, affordable and sustainable food. Its objectives and commitments aim to integrate the positive role that food can play across a range of settings and policy areas. The strategy's six settings reflect this:

- Good Food at Home, and Reducing Food Insecurity
- Good Food Economy, Shopping and Eating Out
- Good Food in Community Settings and Public Institutions
- Good Food for Pregnancy and Childhood
- Good Food Growing, Community Gardening and Urban Farming

- Good Food for the Environment

Following an eight-week consultation this summer, to which 150 stakeholder organisations and thousands of Londoners responded, the London Food Boards have been working to take every piece of feedback into account and ensure the final strategy is robust, ambitious and inclusive in reflecting the food needs of all Londoners. The Consultation Report (available from the London Food Strategy page) details the consultation process and how the comments have been taken into account.

The Implementation Plan sets out the actions the Mayor will take and support between 2018 and 2023 to help implement the strategy's priorities.

[Press release: Planning application submitted for Holocaust Memorial proposed for next to Parliament](#)

Yesterday (19 December 2018) a planning application for the UK's new Holocaust Memorial and Learning Centre has been submitted to Westminster city council.

A fundraising effort for the Memorial will be led by philanthropist Gerald Ronson CBE, who will set up a new charity to support its delivery.

The Holocaust Memorial and Learning Centre has been proposed for Victoria Tower Gardens next to Parliament.

The design for the UK Holocaust Memorial and Learning Centre has been developed over the past year. It has been done in consultation with Holocaust and other genocide survivors, communities of a range of faiths and backgrounds, local residents, businesses and key experts from landscape design to Holocaust education.

Images of the final design were released on 4 December 2018, alongside a Mission Statement setting out the UK Holocaust Memorial's commitment to stand up against antisemitism, prejudice and hatred in all its forms.

By setting history's worst example of the disintegration of democratic values against the greatest emblem of Britain's aspirations for democracy, it will

stand as a permanent reminder of the responsibilities of citizens to be vigilant and responsive whenever and wherever those values are threatened.

Communities Secretary Rt Hon James Brokenshire MP said:

The Memorial will be a place of reflection and education in the exceptional setting of Victoria Tower Gardens, and act as a commitment for all of us to stand up whenever our shared values are threatened.

The planning application submitted today is a key milestone in this important national programme that will deliver a national Holocaust Memorial and Learning Centre at the heart of our civic and democratic life.

Details of the design scheme

In 2016 Prime Minister Theresa May launched a design competition for a Memorial and underground Learning Centre in Victoria Tower Gardens, adjacent to Parliament in Westminster.

The winning scheme was proposed by a team led by architects Adjaye Associates, with Ron Arad Architects as Memorial Architect, and Gustafson Porter + Bowman as Landscape Architect. Their proposal set out to create “a living place, not just a monument to something of the past” and the desire to create an immersive journey for the visitor who would enter a Memorial embedded in the landscape of the Gardens.

The jury found the proposal deftly resolved an essential challenge of the brief: being visually arresting (“highly visible from near and far”) yet showing sensitivity to its location and context (“a bold and sensitive collaboration between architecture, landscape, art and design”). The design was found to have clear potential to be developed into an iconic memorial and powerful educational experience, welcoming visitors from the UK and beyond to learn and reflect.

The final design for the Memorial and Learning Centre consists of 23 bronze fins to the southern end of the Gardens. Visitors will walk through an entrance pavilion, then across a courtyard where they will be confronted with views of Parliament’s Victoria Tower. The Learning Centre, accessed by pathways set between the fins, is an integral part of the Memorial. Visitors will leave with an improved understanding of the Holocaust and its impact on the United Kingdom and people who live here or came to live here following a genocide.

The landscape design embeds the Memorial within the park and includes a new intervention – a subtle but distinct slope which creates a new vantage point to the River Thames, a renewed perspective and relationship to the Memorial, and a distinctive entry point for an underground Learning Centre. This subtle shift in the landscape also allows for all existing memorials within the gardens to remain visible whilst key views into Westminster are undisturbed.

It is expected that consultation letters on the proposal will be sent out from Westminster city council in the new year.
