

Towards a Ceasefire and Political Resolution in Sudan

Two years of brutal civil war have turned Sudan into one of the world's worst humanitarian catastrophes. Over 30 million Sudanese people urgently need humanitarian aid – more than half the population. Yet, despite this scale of suffering, Sudan has received far too little attention here in the UK.

The conflict has shattered communities, forced millions from their homes, and exposed countless civilians to violence, including horrific war crimes. Children have been disproportionately affected, with many denied access to education, healthcare, and safety.

Meanwhile, UK governments have failed to meet the moment. Like the Conservatives before them, Labour has cut international aid budgets. Even where funding for Sudan has been 'ringfenced', it is under severe threat. This damaging retreat from global leadership undermines the UK's ability to help resolve the crisis.

As Liberal Democrats, we believe the UK must lead urgent international action to push for a ceasefire and a lasting political resolution in Sudan – and to provide real support for civilians caught in the conflict.

Today, members have passed new policy calling on the Government to:

- Lead efforts to establish a **Sudan-wide arms embargo** to stop the flow of weapons fueling the war.
- Build international consensus to **resist legitimising warring parties** and ensure that those responsible for war crimes are held to account.
- Reverse its cut to the **UK's aid budget**, and outline a clear timeline for returning to 0.7% of GNI.

Provide targeted support for **Sudanese children**, who have suffered disproportionately and need urgent access to education, healthcare, and trauma-informed services.

Meanwhile, the UK's 2021 National Space Strategy is already out of date, leaving us in danger of falling behind. Without a clearer plan, we risk not only losing global leadership but also missing out on the jobs, innovation, and investment that flow from this fast-growing sector.

Liberal Democrats believe space should be a cornerstone of the UK's future – an industry that drives growth, secures our independence, and inspires the next generation.

Today, our members have passed new policy to put the UK space sector back on track:

- **Renew the National Space Strategy**, focusing on attracting international investment, fostering growth, and ensuring people-centred, efficient regulation.
- **Review and support UK spaceports and hubs** to cement our place as a global space hub.

- **Designate space as a strategic industry** under the National Wealth Fund, opening the door for productive investment in:
 - A UK satellite navigation system to ensure resilience after Brexit.
 - Cutting-edge technologies including quantum communications, satellites, advanced materials, optical infrastructure, and computing.

Champion diversity and inclusion in the space workforce, with schemes to support underrepresented groups, including women, ethnic minorities, and people with disabilities.

The UK space industry already brings in nearly £19 billion a year and employs over 50,000 people. But revenues are slipping, with income falling slightly since 2021, and global competitors racing ahead.

Without urgent action, we risk seeing opportunities and investment go elsewhere.

A renewed space strategy would provide the direction and smart investment to unlock the sector's potential. By supporting spaceports, championing innovation, and making sure the industry is open to everyone, the UK can once again be at the forefront of one of the most exciting frontiers of science and technology.

Building a Fair Asylum System

The UK asylum system is in crisis – and people fleeing war and persecution are paying the price.

For years, the Conservatives trashed the system, letting backlogs spiral out of control and leaving thousands of vulnerable people stuck in expensive hotels. Now, rather than fixing the mess, Labour has doubled down with counterproductive measures like the immediate suspension of family reunion

pathways and reducing the move-on period for new refugees.

This is dividing communities, costing billions, and undermining the UK's proud history of offering sanctuary to those in need.

As liberals, we believe in compassion, fairness and efficiency. That means ending the chaos, restoring dignity, and building an asylum system that works for everyone.

Today, members passed a new Liberal Democrat policy to do this by:

- **Ending the use of asylum hotels by clearing the backlog**, speeding up application decisions, and allowing people with valid claims to work, integrate and contribute while swiftly returning those who do not have a right to remain.
- **Lifting the ban on employment for asylum seekers** who have waited more than three months for a decision.
- **Restoring family reunion pathways** so refugees can rebuild their lives with their loved ones.
- **Tackling dangerous crossings** at their source by stepping up cross-border cooperation and giving the UK a leadership role in Europol to take on the criminal gangs.
- **Reaffirming the UK's commitment to the European Convention on Human Rights (ECHR)** and rejecting any attempt to undermine the rights and protections it guarantees.

Protests over asylum hotels have already put police forces under 'chronic pressure'. Refugees are left in limbo, unable to work and forced into poverty. Families are kept apart. And meanwhile, the toxic rhetoric of Reform and the Conservatives is dragging politics further away from compassion and common sense.

A Liberal Vision for Digital Rights

The internet is one of the most powerful tools for freedom in human history. It connects communities, spreads knowledge, and gives people a voice. But it also carries risks – from the spread of child sexual abuse material to harassment, deepfakes, and the promotion of suicide and self-harm.

The Online Safety Act was meant to tackle these harms. Its aim, protecting children and vulnerable people, is one we all share. But the way the law is being implemented has been disproportionate and ineffective.

Already, political content, educational resources, and wellbeing forums have been caught up in inappropriate age-gating. Age-assurance systems pose real risks to privacy and data protection. And the Act threatens end-to-end encryption, a cornerstone of secure communication, especially for vulnerable groups like LGBT+ communities who depend on online networks for support.

Protecting young people and vulnerable groups online is vital. But it must be done in a way that is effective, proportionate, and rooted in liberal values.

That's why Liberal Democrats have today passed a new policy, put forward by the Young Liberals, calling for a new approach – one that puts people, rights, and safety first:

- **A full Parliamentary review within six months** to examine whether the Online Safety Act is meeting its stated aims, whether it is fit for purpose, and what reforms including further legislation are needed.
- **Stronger scrutiny of Ofcom's implementation** to ensure regulations focus on tackling real online harms, not blocking access to politics, education, or wellbeing resources.

A new Digital Bill of Rights to safeguard privacy, free expression, and protection against online harms – ensuring online regulation works for people, not against them.

Certainty for Ukrainian Children Living in the UK

Since the full-scale invasion of Ukraine by Russia in 2022, the Liberal Democrats have been steadfast in our support for Ukraine and its people. This policy, brought forward by the Young Liberals, reflects our shared commitment to ensuring that being a true friend to Ukraine means more than just standing up for it on the world stage – it means standing up for Ukrainians living here in the UK, especially the thousands of children who have been forced to flee their homes.

Many Ukrainian children in the UK have experienced profound trauma and disruption. Displaced across Europe, they face challenges adjusting to new environments, languages, and education systems. - **Establishing a pathway to indefinite leave to remain** for Ukrainians who have integrated into British life and wish to stay long-term, ensuring security and stability for those making the UK their home.
- **Ensuring Ukrainian pupils and other children with experiences of forced displacement do not face delays** in school enrolment and receive trauma-informed support tailored to their needs.
- **Re-establishing GCSEs and A-levels in the Ukrainian language**, so that young people can maintain ties to their culture and language while progressing academically.
- **Ensuring that Ukrainian-language books and educational materials are widely available** in schools and libraries, supporting language retention and cultural identity.

- **Supporting Ukrainian cultural, educational, and linguistic initiatives** within the UK to foster a welcoming and inclusive environment.
- **Providing guidance and support to Ukrainians accessing further education, higher education, and apprenticeships**, helping them to build successful futures.
- **Offering support to displaced Ukrainians in the UK who wish to voluntarily resettle in safe areas of Ukraine**, helping families reconnect with their homeland when it is safe to do so.
